2. About Us

5. Payments and Membership

All fees and payments for membership, training, or participation in competitive events are subject to our pricing structure, which may change from time to time. Payments are made via secure online methods. We do not store payment details on our website.

6. GDPR Compliance and Data Protection

6.1 Personal Data Collection

In compliance with the General Data Protection Regulation (GDPR), we take your privacy seriously. We only collect personal data that is necessary for managing membership, event participation, and club administration. Personal data may include, but is not limited to:

- Name
- Date of birth
- Contact information (email, phone)

- Medical information relevant to participation in training or events
- Payment details

6.2 Lawful Basis for Processing Data

The lawful basis on which we process personal data is the fulfilment of a contract (e.g., membership agreement) and legitimate interests, such as providing club services and ensuring the safety of participants.

6.3 Data Usage

We will only use your personal data for the following purposes:

- Administering memberships
- Organizing training sessions and competitive events
- Communicating with parents or guardians about club updates, schedules, and important notices
- Ensuring participant safety and well-being (e.g., for medical emergencies)

6.4 Data Sharing

We will not share your personal data with third parties without your explicit consent, except as required by law or where necessary to fulfil our services (e.g., sharing limited information with competition organizers or insurers).

6.5 Your Rights

As per the GDPR, you have the following rights regarding your personal data:

- **Right to Access:** You can request a copy of the personal data we hold about you.
- **Right to Rectification:** You can ask us to correct inaccurate or incomplete personal data.
- **Right to Erasure:** You may request the deletion of your personal data where it is no longer necessary for us to process it.
- **Right to Object:** You can object to us processing your data in certain circumstances.
- **Right to Data Portability:** You can request the transfer of your personal data to another organization.
